## **Invented 'rights'**

Recently, Terence Jeffrey, Editor-in-Chief of *CNSNews.com*, a division of the *Media Research Center* (MRC), observed in obvious frustration:

"...Our nation is being ripped loose from its mooring in natural law. Forty-three years ago, seven members of the Supreme Court declared a 'right' to kill an unborn child. Since then, tens of millions of babies have been aborted.

"A year ago, five members of the Supreme Court declared a 'right' for two people of the same sex to marry. Were there such a right, which there is not, it would mean children do not have a right to a mother — or a father.

"Currently, an eight-member Supreme Court is weighing whether the government can force Christians to act against their faith and cooperate in the distribution of abortifacient drugs that take innocent lives. Thus could the freedom of conscience be curtailed in the pursuit of further diminishing the right to life.

"If the case the Justice Department filed in North Carolina this week makes it to the Supreme Court, the underlying question before the court may be, as it is in the Justice Department's complaint: What is a man and what is a woman? The laws of nature and nature's God answered that question a long time ago. But President Obama's Justice Department has a different opinion."

I would suggest that the current president and his Justice Department lackeys be presented with a panorama of human history, most particularly that of Western Civilization. Then they could easily point to the precise moments where these anomalies can be seen. These must have occurred before in societies where those cultures accommodated the odd exceptions. ## **Sowing confusion**
