Demise of the Iran Nuclear Deal

Pulling the plug

“When people repeatedly threaten to kill you, sooner rather than later you should listen to them,” said a Holocaust survivor, commenting on the Iran Nuclear Deal.

Thankfully, President Donald Trump listened to common sense, deciding to bury another of Barack Obama’s legacy icons by scrapping the Iran Nuclear Deal.

Barack Obama’s plan was to genuflect to Islamist dictators and subject the larger Middle East to Iranian supremacy. His appeasement strategy simply emboldened Iran to forge ahead with its nuclear weapons program. Obama’s plan to abandon Israel and Egypt gave Iranian radicals approval to establish hegemony in the Middle East. “Death to America” chants were ignored.

Former President Obama and his Secretary of State John Kerry were single-minded. Their DOJ even instructed the DEA to “back off” from pursuit and prosecution of Hezbollah drug cartel members bringing cocaine and heroin into the United States through our southern border. Hezbollah, an Islamist terror organization, is supplied and financed by the Iranian mullahs. It was simply a political deal between the Obama Regime and the Iranian mullahs; an arrangement to “look the other way” while Iran completed its plans for a nuclear weapons program, aided by the Red Chinese, Russians, and the North Koreans. It does not have the weight

of U.S. law. It is a hand-shake deal, with no Iranian signatures! Trump knows this.

At the end of April, Israeli intelligence officials stated that Iran was brazenly lying about its nuclear capabilities. Israel Prime Minister Benjamin Netanyahu, in a presentation last week exposing 100,000 files secreted out of an Iranian facility, reviewed the Iranian plan to develop five warheads, each with a ten-kiloton yield.

Netanyahu delivered a PowerPoint presentation that exposed Iran’s lies and revealed the holes in Obama’s Iran Deal. In an IAEA assessment, Iran had denied existence of their plans for an explosive nuclear device. Actual files obtained by Israeli intelligence show that, “Iran authorized, initiated, and funded Project Amad, a coordinated program aimed at the development of a nuclear explosive device.”

Last week, Prime Minister Netanyahu personally thanked President Trump for leaving the Iran Deal, echoing Trump’s words; it was a “horrible, one-sided deal.”

President Trump has called the Iran Nuclear Deal, “Rotten to its core... The Iranian Regime is the world’s number one state sponsor of terrorism.” Facts are facts. In light of the corrupt methods the Obama administration used to seal the deal, and the disinformation their propaganda arm – the U.S. media – fed American citizens, canceling the “Deal” is the right thing to do.

Time to end forced multilingualism

Perpetual War against Freedom

The battlegrounds in the war are numerous and familiar: the university, race relations, popular culture, gender definition, religious practice, etc. In these areas the Left concentrates its daily efforts; its unending attempts to “radically transform” America.

Intellectual constructs that the Left has assembled to support and justify their assault on our nation are several. The largest among these is the idea that “equality” must be *achieved*; the means justified and necessary to accomplish an ideological agenda.

But the equality the Left desires does not exist in nature. Therefore, it must be artificially *created*. As David Horowitz explains, “...Disparities and disproportions of talent, intelligence and physical ability are so intrinsic and so basic to the entire human enterprise that *creating* equality can only be accomplished by violent social engineering, which is why the seductive utopias of the Left always turn out to be killing fields in disguise. The demands for ‘social justice’ by today’s progressives are just another version of the demands for equality by yesterday’s Marxist Leninists. Both promise human redemption. Both produce the destruction of human freedom.”

Raised by parents who were dedicated members of the Communist Party USA, Horowitz deeply understands the objectives of the radical Left and possesses an unparalleled knowledge of the harsh delusions that inform the progressive agenda. He thoroughly understands that the core of this agenda is a perpetual war against freedom, particularly the freedom individuals have to resist its social “redeemers” and their malignant plans.

The Left pursues a continual conflict; it affects everything they touch. Their threats to the survival of American Liberty are sadly ignored by the naïveté of an ignorant, sedate Republican Party that doesn’t grasp the intent of the now radical-controlled Democrat Party and their violent, progressive army.

It’s worrisome that this year’s mid-term primary contests will not even see the agenda of the American Left discussed, or the danger it poses to our republic.

Not long ago, being an American meant speaking English. Yet, sadly, that has changed. Increasingly, Spanish, Korean, Vietnamese, and other languages are required on welfare forms, Social Security documents, election ballots, in our classrooms, on job applications, in restaurants, hospitals, and even in many businesses. In short, America is being transformed from an English-speaking nation into a multilingual nation.

A concerted effort exists to force multilingual policies at all levels of government; to weaken Official English policies passed by local and state governments, even though more than 30 states have English as their official language, by law. Government applied this force with former President Bill Clinton’s Executive Order 13166. That massive, costly, unlegislated order requires every government agency and organization that receives federal funds to provide services and programs in *any* foreign language, opening the door for a surge in the acceptance of multilingualism.

This executive order was crafted by the worst in the political correctness movement and the Washington, DC elite, who don’t believe in the preservation of our nation’s traditions, core values or standards of citizenship. It’s an expensive, virtually impossible task, trying to provide services in 322 languages for government, health care and education sectors. EO 13166 forces every government agency and federally-funded organization to print all documents in multiple languages and provide translators for the non-English-speaking.

In welfare and food stamp offices taxpayers pay the bill for recipients with limited English proficiency (LEP) at a cost of \$1.86 million per year. Oral translations are even more costly, racking up \$21 million in annual taxpayer expense.

Ninety percent of states’ motor vehicle registration offices provide license exams in as many as 30 foreign languages, including Arabic. State budgets are therefore running deeper deficits, forced to pander to a greater number of LEP drivers.

Then there’s the INS (Immigration and Naturalization Service) expense. The CBO (Congressional Budget Office) estimates that the cost of implementing EO 13166 for that agency is between \$114 million and \$150 million *annually*.

By far, the largest expense is in health care. Costs to doctors and hospitals for translators for their non-English-speaking patients are at astronomical levels: \$180.8 million for multilingual out-patient services; \$78.2 million for multilingual in-patient services; and \$8.6 million for multilingual emergency room services. Adding it all up, the health care system costs are crushing at \$267.6 million per year. Medicare is also being hit hard, the funds paid into it over time by American citizens usurped to provide interpreters and printing of health care documents in multiple languages. This money in Medicare belongs to *citizens*.

The misguided policy exemplified by EO 13166 blatantly encourages immigrants to avoid learning English, and thereby delay assimilation into our culture. This short-changes them of the benefits of the success they envisioned by coming to America in the first place and gives them a reduced incentive to embrace the American way of life. But this policy also makes it much easier for *illegal* aliens to survive within the U.S., paid for by taxpayers.

Providing costly multilingual programs and services is absurd. Immigrants must demonstrate proficiency in the English language to become citizens, period. Or has that rule, one that enhances and strengthens our national identity, been ignored also?

There’s no question how the American people spoke in November, 2016. It’s time that progressive plans for a multilingual America, part of their radical “transformation,” end. Before balkanization of America advances further, President Donald Trump must repeal EO 13166.
